CERTIFICATE OF RECOGNITION

Under the powers delegated in the G.O.(Ms).No.196, Social Welfare Department, Dated.10.3.1980 & G.O.(Ms).No.220, Social Welfare & Nutritious Meal Programme Department, Dated.17.12.1999, the Certificate of "Temporary Recognition" is "**St.Joseph's Special School**", Located at- Soosai Thottam, 4/79, Thendral Nagar, Nagamalai, Madurai District- 625019, to function as Pre-Primary, Primary, Secondary and Vocational Classes. This certificate of recognition is valid from the date of issue to 18.11.2025 and is subject to the following conditions:-

1. Qualified Teachers appointed in 1:8 ratio should be maintained scrupulously throughout the recognition period.
2. The Management should run the school in accordance with Provisions of the Tamil Nadu Recognized, Private Schools (Regulations) Act, 2018 and Rules 2023.
3. Application for granting renewal of a certificate of recognition should be submitted to this office two months in advance before the expiry of the period of validity.
4. The institution has **24 Male & 01 Female Children only at present**. Based on the infrastructure the **capacity of the institution is fixed at 150 Children** with disabilities.
5. The Management should not appoint any teachers whose certificates have been cancelled or who have been convicted for offence involving moral turpitude.
6. This certificate should be displayed by the institution in a conspicuous place.

7. i) Structural Soundness Certificate issued by a registered Engineer under sub-section 4 of section 4 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965 – **valid up to 18.11.2025**
- ii) License issued by the competent authority under sub-section (1) of section 6 of the Tamil Nadu Public Buildings Licensing Act, 1965 Act XIII of 1965) – **valid upto 18.11.2025**
- a) iii) No Objection Certificate from Fire Service Department – **valid up to 21.02.2025**
- iv) Sanitation Certificate issued under the Tamil Nadu Public Health Act, 1939 – **valid up to 18.02.2025**
8. The recognition certificate is valid for the period mentioned therein and is subject to the condition that the certificates mentioned in 10 (i) to (iv) above are to be renewed in time before the date of expiry and a copy has to be furnished to the District Differently Abled Welfare Officer of concerned District, failing which the validity of recognition made by this office is deemed to be cancelled from the date of lapse of validity of any of the certificate in para 10.
9. The School authorities should ensure provision of barrier free and easily accessible environment to the students of Special Schools.
10. The Institution is subject to Inspection by the Inspection authorities under the Act / Rules and by the persons / officers authorized by the State Government. This recognition accorded is valid only, if the school is functioning in the address mentioned in this recognition order.
